

Canadian Champions vs. Climate Change Contest Terms and Conditions

1. Eligibility

NO PURCHASE NECESSARY.

This Contest is open to legal residents of Canada, excluding residents of Quebec, who have reached the age of majority in their province/territory of residence. VOID WHERE PROHIBITED BY LAW.
